1) Meeting call to order: 6:25 p.m.

2) Reading of previous meeting minutes: The minutes from the February council meeting were read by Susan. Sam motioned to accept the minutes, Colleen seconded, and all present board members agreed.

3) Treasurer's Report for 01/01/26-12/31/26:
